**VALIDITY PERIOD OF FEES AND CHANGE NOTIFICATIONS:****For Commercial Customers;**

The Bank reserves its right to change the prices that the banks have the freedom to determine as granted by the CBRT(CENTRAL BANK OF THE REPUBLIC OF TURKEY), out of the prices listed above.

The Bank reserves the right to make any changes in the specified fees.

The increases to be made by the Bank shall be notified in writing via permanent data storage device or recorded telephone call in accordance with the provisions of the Communiqué in 2 (two) business days before such increases.

**For Financial Consumer Customers;**

The Bank may increase the fees with regards to the regulations with a notification to the Customer in writing or with any permanent data register or any registered phone at least 30 days in advance of the changes. Upon this notification, the Customer has the right to withdraw from the use of the product or service until 15 days after the start of the new period. In case of exercise such withdrawal right, the Bank shall not request any additional interest or fee from the Customer for the new period. The Bank is entitled to discontinue the relevant service offered to the Customer, using the right of withdrawal. The Bank shall additionally get the approval of the

Customer for any amendments, which anticipate increases in fees charges and commissions higher than the rate anticipated by the relevant laws and regulations. Upon acceptance of the Bank's offers regarding the banking products delivered to the Bank by using the products, the Customer agrees to pay the fees, commissions and charges applicable on the date of use of the product.

You have the right to waive from using the product or service until 15 (fifteen) days after the date of such notification. If you use this right, no additional


fee shall be collected from you as of the effective date of the increased fees. If you do not use the right to waive until the end of this period, the increase in fees shall be applied. If you exercise your right to waive, our Bank is entitled to suspend the product or service in dispute.

**FORM OF COLLECTION:**

Collection is made in cash or on account. The Bank will be authorized to debit to and set off from such account(s) of the Lessee including overdraft account and credit card both upon request of the Lessee.

Any further information besides those summarized above is provided in the Agreement; and a copy of this form is delivered to you in addition to the Safe Deposit Box Rental Agreement in order to allow you to read them carefully and to request further detailed explanation from our Bank on any issues that you cannot clearly understand.
